



MEMORANDUM OF UNDERSTANDING

1. SUBJECT

The Chasing Malaria Program in Central Province, Papua New Guinea (PNG)

2. PURPOSE

This document establishes an agreement between the parties listed above to contribute towards the **Chasing Malaria Program** with a AUD82,000 grant from RAM Australia to RC Port Moresby PNG for implementation by Chasing Malaria Program Ltd. for Rotary year 2020 - 20.

4. LOCATIONS

Six (6)) schools in three locations in Central Province – locations to be reported to RAM Australia in first Quarterly Report.

5. SHARED GOALS

All parties listed in this agreement will collaborate to achieve the following shared goals:

- a. Ten (10) percent or more of school children received six monthly malaria surveys that included physical assessment and rapid diagnostic testing.
- b. All school children who tested positive for malaria are given treatment with follow up care.
- c. All school children tested positive for malaria are given bed net and malaria education to parents
- d. One school club is established in each school to educate the children in weekly larval source reduction

6. RAM AUSTRALIA RESPONSIBILITIES

RAM Australia will conduct:

- a. Desk review of all reports, to monitor progress of project activities
- b. Conduct yearly evaluation of the project, including a financial review.



- c. Report on the Program in RAM Quarterly Newsletters and at the annual National RAM Conference

7. CHASING MALARIA PROGRAM LTD: IMPLEMENTATION ORGANIZATION RESPONSIBILITIES

The Implementation Organization will:

- Submit the name of one contact person responsible for liaising and providing reports to RAM Australia before project commences.
- Submit pre-project implementation service data on selected project locations and schools in the project, to RAM Australia
- Provide expertise, infrastructure, training, education, or other support for the project
- Keep an Accounts Ledger
- Submit Quarterly itemized expense statements and receipts to the RAM Australia
- Submit timely Quarterly Report on activities and results to RAM Australia
- Conduct an evaluation of the project activities at the end of 12 months.

8. MUTUAL UNDERSTANDINGS

All parties agree that:

- a. The Grant AUD82,000 is awarded to RC Port Moresby for the Chasing Malaria Program in the agreed location/s.
- a. The RC Port Moresby will provide oversight of activities funded by RAM Australia for the Chasing Malaria Program.
- b. The Chasing Malaria Program Ltd will submit quarterly report to RAM Australia on all stages of the Chasing Malaria Program during the 12 month period.
- c. The RC Port Moresby PNG affirm that Chasing Malaria Program Ltd is reputable and responsible, and act within all laws of the project country.
- d. Maintain a standard set of accounts, which includes a general ledger and a complete record of all receipts and all disbursements of grant funds
- e. Chasing Malaria Program Ltd project-related documentation may be subject to independent financial and operational review by the RAWCS Ltd. Auditors.








